Comment on Voter Photo ID

Deadline: June 23rd - Do it NOW!

Comment on two proposed temporary rules to implement photo ID requirement for in-person and absentee-by-mail voters, beginning with the 2023 municipal elections.

You can be certain that the Left will complain about photo ID rules, so let's reiterate what we want: **"Make it easy to vote, hard to cheat."**

- We want confidence in our voting system.
- Virtually every American has a photo ID.
- Stop voter fraud.
- Ensure that mail-in ballots are legitimate.
- One person, one vote.

Proposed EPA Regulation Eliminates Most Family Vehicles

The Environmental Protection Agency (EPA) proposes strict emissions standards to virtually regulate passenger cars, pick-up trucks, vans and SUVs out of existence.

In just 9 years, these radical proposals will force most families to buy electric vehicles (EVs).

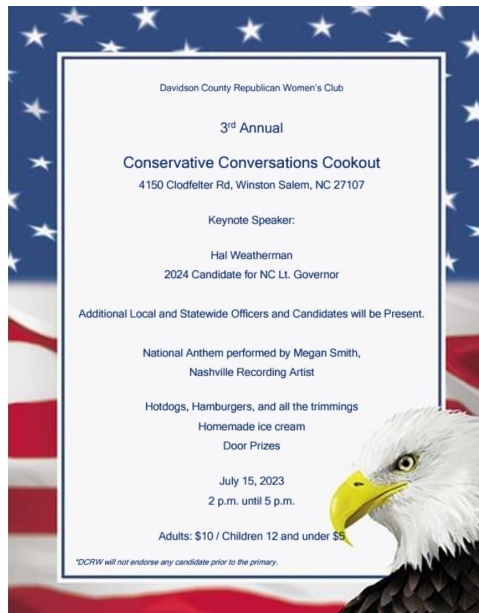
