



## STUDENT LOAN ALERT Deadline February 10th



### **It's your right and your responsibility as a citizen.**

The Biden administration is at it again with plans that will further wreck our economy.

Push back by commenting **TODAY** in the Federal Register. Tell the Department of Education (USDOE) that they have no business forgiving or cancelling loans when loan repayment plans already exist.

Named "Improving Income-Driven Repayment for the William D. Ford Federal Direct Loan Program," this proposal is mass debt cancellation.

For those who worked their way through college or sacrificed to send their children, this is an insult. For those who did not to go, or could not afford to go to college, and instead went straight to work, this proposal unfairly forces them to pay another's debt.

- Costs over \$100 billion.
- Undermines Congress' legislative authority.
- Bribes voters.
- Partially cancels debt for 98% of college graduates.
- Creates a larger national debt that our grandchildren will pay.
- Raises tuition costs for future students.
- Cuts millions of loans by more than 75%.
- Offers up to \$20,000 in loan cancellation to millions of borrowers.
- The USDOE currently has loan repayment plans in place.
